## News from the School of Mathematics and Sciences

Associate Professor of Conservation Biology and Director of the Cumberland Mountain Research Center, **Dr. LaRoy Brandt** recently had two research manuscripts accepted for publication and currently in press. These articles are examples of the continued effort of the CMRC to facilitate faculty research.

The first article represents a CMRC collaboration with the Smithsonian Institute and their SNAPSHOTUSA project for eMammal. This research represents a collaboration of wildlife biologists from all 50 states where researchers place trail cameras out simultaneously through September and October to assess the mammalian biodiversity across the entire US. We are now approaching our third year of participating in this project. This current article is a summary of the first year's data and is published in the journal *Ecology*. The CMRC is expecting to expand its participation to include additional locations during this fall's research season. Although not in print yet, the article can be found at the following here.

The second article is a One Health article that was accepted to the *American Journal of Primatology* and represents a collaboration between the University of Toronto, the CMRC, and Regis University. This article summarizes some of the ongoing efforts of Dr. Brandt's affiliation with the Maderas Rainforest Conservancy and a number of other researchers at the LaSuerte Biological Research Station. Over the past 15 years, Dr. Brandt has had the opportunity to assist and advise the evolution of the Maderas Rainforest Conservancy Mission to what would now be considered a Tropical One Health Program that includes not only monitoring the health of the rainforest, but facilitating veterinary and medical missions to rural Costa Rican and Nicaraguan in addition to serving as a resource to local communities and ranchers about more sustainable practices. One current result of their efforts is that Dr. Brandt is also serving as an advisor to the Costa Rican government through the Maderas Rainforest Conservancy on the development and implementation of a biological corridor that will connect national parks in the Central Range to the Tortuguero National Park on the Caribbean Coast. Additionally, this has led to increased collaboration between the Maderas Rainforest Conservancy and palm oil plantations contiguous with the LaSuerte Biological Research Station as he is now advising the plantation owners on developing land management and harvesting practices that will improve the biodiversity of the region and ecosystem health. ## LMU Mini-Grants

The LMU Mini-Grants Program is intended to support and encourage scholarly activity at LMU. The LMU Mini Grants committee evaluates proposals and makes recommendations to the Committee on Scholarly Activity (COSA). Grants are awarded for a one-year period.

Applications will be invited for projects requesting up to \$8,000 in support. The number of awards made will be dependent upon the amount of funding available and the evaluation of applications made by the committee. A faculty member may receive no more than one award per fiscal year.

### **Eligibility**

Full-time faculty/staff of the University are eligible to apply for funding. Consideration will be given to those projects that are collaborative and initiate an ongoing program of research, and/or have the potential to lead to external funding.

### **Application Deadline**

February 1st of each year

### **Review Criteria**

Mini-grants will be reviewed and awards made on the following basis:

- Availability of funds
- Research merit (originality, research significance, research design, predicted outcome, previous research achievements of the applicant, etc.)
- Broader impact (the likelihood that the project will either produce or be incorporated within published material; the potential for external funding, etc.)

### **Notification of Funding Awards**

Applicants will be notified in writing as to the funding decision on their proposals by April 1st and the award start date is May 1st.
