North Carolina: A Sense of Home, Selections from the Do Good Fund. The Bascom Museum, Highlands, NC. I will be giving a series of artist talks and photography tutorials as part of the weekend event, *The Bascom Celebrates Photography* May 12-14.

Boillit is currently acting as Project Director of the Cumberland Gap Folklife Project funded by the National Endowment for the Arts and the Tennessee Arts Commission. The project has resulted in dozens of audio interviews, hundreds of hours of video footage, and hundreds of photographs documenting local artists and musicians. New programmatic activities at the annual White Lightning Trail Festival this June 24 will additionally showcase the work of these regional bearers of tradition, as well as new poems and artworks made by LMU students through a series of apprenticeships. You can find the poems and art pieces on display at LMU's Art Center this summer for the annual Arts in the Gap exhibit. Six LMU students have been provided jobs with this grant funding. Finally, video footage will be edited for a 6-episode public television series, as well as a distinct documentary feature film, to be premiered in 2018.

Assistant Professor of Education, Joy Collingsworth is currently the Co-Project Director of the 2017 Improving Teacher Quality Grant. This grant is working in partnership with the Clinch Powell Educational Cooperative to provide professional development in the STEM area to teachers that work in six of our surrounding counties. LMU will host a three-day intensive institute where participants will be housed on the Harrogate campus and will be immersed in workshops, reflective sessions and working meals. This program represents a collaborative effort among LMU's School of Mathematics and Sciences, LMU's School of Education, and the Clinch Powell Educational Cooperative. Collingsworth is working with Associate Professor of Biology, Aggie Vanderpool on this project.

Joy is also working with Claiborne County on their 21st Century Afterschool Program Grant. This grant would benefit education students, giving them hands-on training while in the schools of Claiborne County. This grant is in the process of being written and will hopefully be funded later in the summer of 2017.

Grant writing is not a complicated process, but does require attention to detail. All funding organizations have a responsibility to their stakeholders to ensure that the money invested in a grantee's program accomplishes their purposes and furthers the mission of the foundation. To assure the board of directors, the program officer, and grant review committee that their money is being well spent, the grant narrative needs to be clear and concise.

Included in the narrative are objectives, which need to be SMART: Specific, Measurable, Achievable, Realistic, and Time-based. There is no way to budget for a program without knowing who the program is intended to serve and how many people will be involved. The objectives explain how the program will operate within the community and the time it will take to run the program. With that outline in mind, the basic questions can be asked.

Who are the people impacted by the program? The grant application may ask for specific age ranges, socio-economic data, and demographics of gender and race. How many people will participate? This may be an estimate, but it is important to know for budget purposes. Where will the program take place and who will direct activities, staff and volunteers, if any? What is the activity schedule and how long will the program run? Are there sufficient resources to operate the program and is there support from the administration? This question is extremely important for budgeting purposes. Assessing faculty/staff time is critical. Will the program director need 10 percent of her time to devote to the program? Make sure this is reasonable. Does the program require special equipment, materials, and any other incidentals such as T-shirts, pens, paper, books, computers? Details in the budget are essential.
